# NOTES & QUOTES

■ **Creation Scientists Answer Their Critics** is the title of a new book by Dr. Duane Gish (1993, Institute for Creation Research). It provides an up-to-date rebuttal of evolutionary arguments and answers many of the charges leveled against creationists. Dr. Gish has faced evolutionists in nearly 300 debates, and by their own admission, he usually wins. The following quotes are from this fascinating new book. (Page numbers are from Gish's book. Full references given in his book.)

■ Gish first gives a short history of the creation/evolution debate then shows that neither evolution nor creation can be tested by ordinary scientific means and that evolution is just as religious as creation. Several quotes from evolutionists support his thesis:

□ (Evolution) is a general postulate to which all theories, all hypotheses, all systems must henceforward bow and which they must satisfy in order to be thinkable and true. Evolution is a light which illuminates all facts, a trajectory which all lines must follow -- this is what evolution is. (Teilhard de Chardin, p. 28)

□ The fact of evolution is the backbone of biology, and biology is thus in the peculiar position of being a science founded on an unproved theory -- is it then a science or a faith? Belief in the theory of evolution is thus exactly parallel to belief in special creation -- both are concepts which believers know to be true but neither, up to the present, has been capable of proof. (Matthews, pp. 29, 30)

□ It is as a religion of science that Darwinism chiefly held, and holds men's minds....The modified but characteristically Darwinian theory has itself become an orthodoxy, preached by its adherents with religious fervor, and doubted, they feel, only by a few muddlers imperfect in scientific faith. (Greene, p. 31)

□ Just as pre-Darwinian biology was carried out by people whose faith was in the Creator and His plan, post-Darwinian biology is being carried out by people whose faith is in, almost, the deity of Darwin. (Patterson, p. 31)

■ Gish goes on to expose some of the tactics used by evolutionists to discredit creationists, including accusations of "distorting science, quoting out of context, misquoting, and outright lying." (p. 71)

□ To analyze creationist literature is to scale a fortress of facts and quotations taken from the evolutionary literature, distorted and quoted out of context, haphazardly glued into a defense around their faith. (Futuyma, p. 73)

□ Creationists are the liars, freely slinging mud at all who cross their peculiarly myopic view of the natural world. (Eldridge, p. 74)

■ Gish counters these **false claims** with specific examples and lengthy quotes to show that his statements were not misquoted or taken out of context. He also gives several examples of cases where evolutionists had used "tricks" and "chicanery" in debates to win over the audience, or hammered upon a very minor error while ignoring the major challenges set forth by creationists. In one debate, the evolutionist used a slide showing a series of mammal-like reptiles, supposedly intermediates between the two groups. Upon obtaining documentation for the illustration, Gish found that:

□ 1) two of the "intermediates" in the series were totally hypothetical, 2) hypothetical structures had been added to some of the "intermediates," 3) the "intermediates" were not arranged in a true time sequence, and 4) the "intermediates" were not drawn to scale. (Gish, p. 92)

■ Imagine what would have happened if a creationist had used a slide like this! Gish goes on to address issues relating to the fossil record and thermodynamics. He then deals specifically with several of the major books attacking creationism. He ends his book with a chapter entitled, "Out of Their Own Mouths." Here is a "teaser" from this fascinating chapter:

□ I believe that one day the Darwinian myth will be ranked the greatest deceit in the history of science. (Lovtrup, p. 367)

□ So heated is the debate that one Darwinian says there are times he thinks about going into a field with more intellectual honesty: the used-car business. (Begley, p. 367)

□ Suddenly the study of evolution was in all the schools. The culture of the dominant class had triumphed, and traditional religious values, the only vestige of control that rural people had over their own lives and the lives of their families, had been taken from them. (Lewontin, p. 371)

# SPOTLIGHT ON SCIENCE

## An Interview with Dr. Duane Gish

Eighteen years ago, our research into the field of origins began when we read **Evolution, the Fossils Say No!** (Current title: **Evolution: Challenge of the Fossil Record**) by Dr. Duane Gish of the Institute for Creation Research. Since then, we have had the privilege of doing seminars with Dr. Gish on several occasions. The following comments are excerpts from a conversation we recently had with him.

**Q:** What are the chief arguments your opponents usually put forth in debates?

**A:** The chief arguments they will use involve the argument the earth is very old and I always say that's irrelevant, because first of all, creationists take both positions, and secondly, I don't care how old things are, **it's not old enough**. ... Fred Hoyle assumed the universe was 20 billion years old, in his calculations -- He couldn't get life in 20 billion years.

They'll also argue about the geological column and the order in which fossils appear. ... I always mention that there are some creationists who believe in the Day-Age Theory ... Then I point out the alternative interpretation -- the Flood Theory and so forth. And finally I say again it's irrelevant because for example we know that the buggy preceded the Model T Ford and the Model T Ford preceded the Model A Ford and so forth, but we know at the same time that the buggy did not evolve into the Model T Ford. The evidence for evolution must be the actual existence of transitional forms and they don't have those transitions -- absolutely none. ...

Another argument they'll bring up is that there are some examples of transitional forms -- Archeopteryx, mammal-like reptiles. My response to that is this, that we could argue forever whether or not Archeopteryx is or is not a transitional form. We may argue forever whether or not mammal-like reptiles constitute transitional forms -- and I would argue very strongly they do not -- but, let's go back to where there is no question concerning the evidence -- the sudden appearance of the vast array of fully-formed, complex invertebrates. The evidence is very clear.

Furthermore, [regarding] the assumption that an invertebrate evolved into a fish -- again the evidence is very clear. Every major kind of fish appears fully formed, there's not a trace of an ancestor, not a trace of a transitional form. And I say that settles the matter -- we've already settled it. That establishes from the

fossil record that evolution has not taken place on this planet. Now why argue about Australopithecus or Archeopteryx -- you've already settled the matter, you see. We **know** that evolution has not taken place.

When I challenge my evolutionary opponents, with all this vast array of invertebrates and no transitional forms, and the fishes with no transitional forms, despite the assumed 100 million years of evolution, how do they explain that? They don't say anything. They don't even respond. They just ignore my challenge.

**Q:** You frequently use the Second Law of Thermodynamics as evidence against evolution. How do your opponents deal with this argument?

**A:** They always come up with this old idea, "Well, it applies only to closed or isolated systems." [But] the universe **is** an isolated system, it **does** apply to the origin of the cell.

A lot of times the evolutionists will say, "Well, look, a fertilized egg develops into an adult. You mean to tell me that violates the Second Law ..." I always say, "I have no problem explaining the existence of babies - - if you have parents! But you have to explain the existence of babies with no parents! That fertilized egg has all the genetic information, all the metabolic machinery to produce the adult."

**Q:** What do you think is the evolutionist's **strongest** argument?

**A:** Well, their **only** argument really, as far as I'm concerned, is the geological column, with the assumption that all these invertebrates existed before the fishes, the fishes existed before the amphibians ... And of course, very often things don't occur in that order. ... David Raup said that he thought it was a mistake for creationists to use their Flood Model to explain a regular progression of the fossil record that doesn't even exist. ... Even Gould in one of the articles he published argued against the so-called progression.

[Ed.] And so it goes. It appears that the evolutionists still haven't dealt with the creationist challenges and according to Dr. Gish, there's one question they **don't even try to answer** -- the amazing metamorphosis of a caterpillar into a butterfly by step by step mutations. We like the classic response given by one "expert" evolutionist to this problem: "Well, actually today we believe, rather than the caterpillar coming first and then the butterfly, the butterfly came first, then the caterpillar. But we cannot explain that either."
